

**Walk-On's Independence Bowl
December 27, 2018 at 12:30 pm
Ticket to Drive Terms and Conditions**

1. Eligibility: Ticket to Drive (referred hereto as "Sweepstakes") is open only to individuals who are 18 years or older on December 27, 2018 and who purchase a ticket to the 2018 Walk-On's Independence Bowl thru either an individual ticket purchase or a sponsorship. The Sweepstakes is only open to legal residents of the United States of America and is void where prohibited by law. Paid employees of Gateway Tire & Service Center, Yokohama Tire Company, and the Independence Bowl Foundation (Collectively the "Sponsor") and their immediate family members (which means spouse or children) and/or those living in the same household of each are not eligible to win. The Sweepstakes is subject to all applicable federal, state and local laws and regulations. Void where prohibited.

2. Agreement to Rules: By participating in the Sweepstakes, you agree to be fully and unconditionally bound by these Rules, and you represent and warrant that you meet the eligibility requirements set forth herein. In addition, you agree to accept the decisions of Gateway Tire, Yokohama, and the Independence Bowl Foundation; as final and binding as it relates to the content. The Sweepstakes is subject to all applicable federal, state and local laws.

3. Sweepstakes Period: All 2018 Walk-On's Independence Bowl game tickets purchased thru either an individual ticket purchase or a sponsorship prior to 5 p.m. on December 26th 2018 will be eligible to win.

4. How to Enter: The Sweepstakes must be entered by purchasing a ticket to the 2018 Walk-On's Independence Bowl either in person at 401 Market Street, Shreveport, LA 71101, online at www.WalkOnsIndependenceBowl.com, or by mail with an official ticket order form, which can be acquired at 401 Market Street, Shreveport, LA 71101. Entries must fulfill all sweepstakes requirements, as specified, to be eligible to win a prize. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Sponsor. The use of fraudulent methods or other attempts to circumvent the rules may cause a submission to be removed from eligibility at the sole discretion of Sponsor.

5. Prizes: Sponsor has subscribed to www.random.org to assist with the drawing of the four finalists. Four finalists and four alternate finalists (in the event one of the four finalists declines to participate) will be drawn at random using www.random.org on December 26th, 2018 or such other time prior to kickoff of the Walk-On's Independence Bowl that Sponsor shall determine. During the first quarter of the Walk-On's Independence Bowl, Sponsor's representatives will locate the four finalists. At such time, each finalist will be required to furnish the actual ticket and also sign an acceptance of these terms and conditions, and furnish a government-issued photo-identification, such as a driver's license, passport, U.S. military ID or permanent resident card.. The four finalists will receive credentialed access to the field at Independence Stadium for HALFTIME ONLY. Each finalist will draw an ignition key; and the finalist with the key that starts the vehicle will win the Grand Prize, a 2018 Ford F-150 truck, with a retail value of \$37,431. Actual/appraised value may differ at time of prize award. The specifics of the prize shall be solely

determined by the Sponsor and may be changed in Sponsor's sole and uncontrolled discretion with no responsibility on the part of Sponsor to revise these terms and conditions. Sponsor shall have no liability to anyone who claims to be a Finalist but is unable to produce their game ticket.

The receipt by winner of the prize offered in this Sweepstakes is conditioned upon compliance with any and all federal and state laws and regulations, including any obligations by winner to pay any income, transfer, or any and all other state or federal taxes required. Rights Granted by you: By entering this contest you understand that Gateway Tire & Service Center, Yokohama and/or the Independence Bowl Foundation, anyone acting on behalf of Gateway Tire & Service Center, Yokohama and/or the Independence Bowl Foundation, or its respective licensees, successors and assigns will have the right, where permitted by law, without any further notice, review or consent to print, publish, broadcast, distribute, and use, worldwide in any media now known or hereafter in perpetuity and throughout the World, your entry, including, without limitation, the entry and winner's name, portrait, picture, voice, likeness, image or statements about the Sweepstakes, and biographical information as news, publicity or information and for trade, advertising, public relations and promotional purposes without any further compensation.

Sponsor reserves the right at their sole and uncontrolled discretion to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Sweepstakes or violates these Terms & Conditions.

Sponsor has the right, in their sole discretion, to maintain the integrity of the Sweepstakes. 15. Prize Value and Tax Estimation. The invoice price for the prize is \$37,431.00. The federal income tax is \$8,983.44 and the state income tax is \$1,871.55. The total of both federal and state income taxes is \$10,854.99. You agree to pay this amount in full to the Independence Bowl Foundation before taking possession of the prize.
